# MTO LAND CLAIM UPDATE

CONFIDENTIAL NOTICE TO MEMBERSHIP OF MAGNETAWAN FIRST NATION

# MTO OFFER OF SETTLEMENT

The Ministry of Transportation ("MTO") has made its final offer to settle the provinces unlawful taking of 3.75 acres of reserve land for the Byng Inlet Station Road, also known as Highway 645. MTO accepted this grievance as no Order In Council existed authorizing this taking and the taking constituted an instance of trespass. Other historic grievances submitted by Magnetawan First Nation ("MFN") that related to the 1883 North West Road and the construction of Highway 529, are not being addressed as part

2-12 of this settlement.

Council has decided to recommend the settlement of the Highway 645 Claim to MFN's membership. The settlement of the Highway 645 Claim will be on a without prejudice basis to MFN's ability to continue to pursue the settlement of the 1883 North West Road Claim and the Highway 529 Claim. Council

13 will continue to pursue settlement of these other issues.

#### FINANCIAL:

For purposes of the offer of settlement, MTO has offered to pay compensation to MFN in the amount of \$1.2 Million.

#### ADDITIONS TO RESERVE:

The MFN reserve land on Highway 645 is located is subject to the MFN Land Code. The MFN Land Code provides that MFN reserve land cannot be surrendered, but only exchanged. The MFN Land Code provides for a one to one ratio for land exchange. That is for every agree that MFN decides to give up, if

- vides for a one to one ratio for land exchange. That is for every acre that MFN decides to give up, it must receive an acre of land that is at least of equal value.
- For Purposes of the proposed settlement, MFN will receive replacement land on a three to one basis.

  That is for every one acre that MFN gives up, MFN will receive three acres in exchange.

#### TRUST DEVELOPMENT:

Council as an obligation to ensure that the compensation benefits not only benefit the current membership, but also protects that interests of minors as well as future generations. To accomplish this end Council will be developing a trust in consultation with the members to receive settlement funds.

## COUNCIL RECOMMENDATIONS:

Council has reviewed the offer with our negotiation team and has agreed to proceed toward the drafting of a settlement agreement and a trust and to engage in a consultation process with our memberships prior to a vote of the membership on the settlement package.

The offer will need to be ratified by referendum by the membership of MFN following extensive review, analysis and communications (including public meetings with the membership) This will allow the membership of MFN to make fully informed decisions on whether to accept the settlement or not. **Next Steps:** Draft settlement Agreement with related documentation, Draft Trust Agreement in consultation with membership, Consult with membership to explain settlement agreement and answer questions, organize the ratification process and conduct the referendum.

#### **PLANNING**

Economic Plan - 5 year

MFN applied for and received \$80,000.00 from INAC to develop a 5 year economic development plan. Keewin Consulting was engaged and worked with the MFN citizens to complete and implement the plan which included the new store enterprise which was completed and opened in February 2017.

Keewin also assessed the store operations and developed a policy/procedure handbook for the store.

#### **Energy Plan**

MFN applied for and received \$80,000.00 from IESO to develop an MFN Energy Plan. SBA Consulting is engaged and working with the MFN citizens to complete and implement the MFN Energy Plan. The Project is scheduled for completion on Dec 31, 2017.

#### 20 Year Capacity Plan

MFN applied for and received \$170,000.00 from INAC and FEDNOR to develop a 20 Year Capacity Plan. Neegan Burnside Consulting is engaged and working with the MFN citizens to complete and implement the MFN Capacity Plan. The Project is scheduled for completion on June 2017.

It is as a result of MFN having an economic plan that has been accepted by the community that we are able to acquire approvals on our funding requests.

Being financially accountable and compliant with the terms and conditions of our existing agreements is also a major contributing factor.

#### **PROJECTS**

The following projects have been acquired for MFN to participate in and provide temporary employment for our Members.

AFORC - Walleye assessment - employed 6 Members

AFORC - Lake Sturgeon assessment - employed 6 Members

Great lakes Guardian Fund - River Trail - Employed 4 Members

Old Cemetery cleanup - Employed 2 members

Wetland mapping in partnership with McMaster University

The Species at Risk Program has been in place for 6 years thanks to funding from AFSAR. MFN employs 1 full time employee and 2 summer students.

## Hydro Pole and line Relocation -

There were 2 projects which we undertook with Hydro.

We received \$25,000.00 for the 1st one which we had 1 member employed.

We received \$45,000.00 for a contract which we undertook and employed 4-6 members Through the negotiations we obtained the installation of 3 phase power strung from the railroad tracks along 529 Highway to the store location.

#### Traditional Mapping:

Funding in the amount of \$50.000.00 was acquired from the Ministry of the Environment and Climate Change for an 18 month project ending on July 3, 2017 to preserve and share traditional stewardship knowledge which will assist in identifying Magnetawan First Nation Traditional Territory. Wilmer Noganosh III is employed in this position.

#### Participating with the U.O.I. with the development and creation of F.N. Laws:

MFN Ratified the Education Law November 26, 2016

MFN Ratified the MFN Chi-Naaknigewin (Constitution) November 26, 2016

The Anishinabek Citizenship Law

The Anishinabek Election Law

The Anishinabek Child Well Being Law including the development of our own CAS designation along with our Tribal Treaty partner First Nations including Shawanaga.

Council is participating with the Anishinabek Governance Working Group working on the Government Fiscal Funding Arrangement dealing with First Nation Governance Administration requirements.

#### Justice Restoration

Sept.20, 2016 Magnetawan, Henvey Inlet and Shawanaga First Nations partnered to apply for and obtained \$65,000.00 in funding from the Ontario Ministry of the Attorney General to work together on the Justice revitalization Initiative which is to be completed by the end of March 2017. A wrap up report will be distributed to each First Nation to be shared with their citizens

Rosemary Simmons was hired to be the Project Coordinator and Lloyd Noganosh was also employed to be her assistant.

## **Business Development**

#### SHWE MIIKAN

MFN, HENVEY and SHAWANA CHIEFS collectively negotiated for and obtained \$500,000.00 and equally invested with Henvey and Shawanaga in the Shwe Miikan business to obtain a share of the work in the construction of the 400-69 highway.

MFN, HENVEY and SHAWANA CHIEFS also collectively negotiated for and obtained \$200,000.00 each for the establishment of a capacity building account for the future development of business entrepreneurships.

Note - 4 MFN members were trained as Heavy Equipment Operators.

Note - A back hoe was purchased for the use of our F.N. and for contractual work.

We obtained a contract for the hydro pole work and leased out the equipment and provided work for our citizens.

MFN, HENVEY and SHAWANA CHIEFS also collectively negotiated for and obtained a committed set aside for the opportunity to obtain contracts to participate in the construction of the new 400 Highway which will contribute to our First Nations in capacity building for the future development of business entrepreneurships, as well as enhancing Shwe Milkan in expanding and growing its capabilities.

MFN, HENVEY and SHAWANA CHIEFS also collectively are in negotiations for the contract to maintain the new Highway 400 when completed, from the beginning of Henvey territory extending throughout and to the end of all 3 of our respective territories.

MFN, HENVEY and SHAWANA CHIEFS also collectively negotiated for the sole sourcing of the 7182 contract for Shwe Milkan.

SHWE Milkan obtained the contract for the 7182 roadwork project and split the profit of which MFN earned \$60,000.00 which was put into the MFN capacity building account we established to be utilized for skills training and capacity building. MFN members were employed for the project.

Chief is currently negotiating with MTO regarding the Culvert work that is up for contract on 529 MFN reserve land. MTO has agreed to pull this portion from the contract and sole source it to either MFN or Shwe Milkan. It is MFNs choice.

#### GAS STATION

A fuel supply agreement was negotiated with Parkland to supply branded ESSO fuel at a better cost as we established larger volume purchases. To accommodate the larger fuel volumes we purchased a 60,000 liter fuel tank.

A new gas station and convenience store including a Tim Horton's was built and opened in February 2017.

MFN obtained \$700,000.00 in CORP funding from INAC for the business project.

#### Old Store/Gas Bar Fraud 2015-16:

We launched a police investigation and filed an insurance claim for the loss incurred.

We are happy to note that we received a settlement on March 17, 2017 from our insurer in the amount of \$150,000.00 for the loss incurred.

The funds have been returned to the store to be applied to the cost of the new Gas station.

#### STORE FRAUD SETTLEMENT

MFN filed an insurance claim for the losses at the gas bar/store which occurred in 2015-16.

A loss settlement was received on March 10 for \$150,000.00 which has been applied to the store to be used for the upgrade of the new store.

#### HOUSING

There always has been a need for on reserve housing and this has been compounded with the growth of our population and the economic development which has and will continue to create jobs for our citizens and surrounding communities.

#### CMHC:

MFN obtained a loan guaranteed CMHC mortgage of \$272,000.00 and completed the construction of a prefab 2 unit house located on the corner of Village and subdivision Road.

MFN also applied for and obtained a housing grant of \$878,000.00 from INAC to construct 3 additional 2 unit houses. MFN has committed to contribute \$270,000.00 toward the 3 units.

The units are currently being constructed for completion and delivery by July 2017,

2 members were employed and paid by Champois as part of the deal to purchase the prefabs.

#### **Housing Administration**

Rental collection continues to be a problem impacting MFN. The arrears have accumulated to over \$200,000.00. The band is responsible to pay the monthly mortgage on the CMHC units and the monthly payments are automatically taken from the housing account.

Ron Maleau has taken on the role as housing administrator and has so far addressed paying on a monthly basis and is attempting to get the arrears collected.

MFN obtained funding of \$35,000.00 to update and develop housing policies and this will hopefully help to better manage the housing on MFN.

# Education

Council is actively participating with the U.O.I. on the KEB Board as a member of the Board working on the development of our Anishinabek Education System.

Council CONTINUES TO WORK with the Ministry of education on the development of a Master Framework Agreement for First Nation's students and communities.

Chief and Council ensured that no qualified post secondary band member both on and off reserve was denied funding to pursue their education.

MFN education Councillor Carol Stevens continues participating as the First Nations Trustee on the Near North School Board.

An After School Program is provided for the students with a focus on recreation activities as well as social

#### YOUTH

The Youth were provided an opportunity to participate in the following workshop gatherings.

- Lake Huron Treaty Gathering Gabriel Trodd
- Children in CAS Foster Care Gabriel Trodd and Terry Jones
- Feathers of Hope Youth Frank Salerno
- F.N. participation on Juries Terry Jones

The students both on and off reserve are provided an annual Back to school Supplies allowance.

The student both on and off reserve are also provided a winter clothing allowance

The Youth under the age of 18 are provided a \$400.00 subsidy annually per child to participate in a registered sporting activity.

March 2017 Chief obtained donated hockey equipment for distribution to the youth.

The youth and families are annually provided a subsidy to attend and participate in the Little NHL Hockey event. The Youth and families are encouraged to fund raise throughout the year.

Provide summer jobs for the youth that are of age to be employed

Provide annual summer trip to Wonderland

### **ELDERS**

We support and provide services to the seniors and elders of MFN. They are as follows:

We provide a monthly box of nutritious food

We hold a nutritious Bingo where everyone goes home a winner of a food bag or more.

We provide a day for Elders to gather and dine together monthly

We have a drop in for programs and crafts for the elders/seniors.

We have a monthly trip for shopping, bingo and dining

We have the grass cut and the snow shoveled throughout the year.

We provide housekeeping help for those who request and register for it.

Staff are available for walk-in support, conversation and help

We provide local trip around the community area

We also provide some home Maintenance support

We provide medical transportation

We pay for prescription that are either not fully cover or not covered at all

We provide transportation vouchers for those who need them.

We provide large bins for community and household cleanup Pickup by Public works.

We also pay annual dump fees and provide trash collection weekly

We provide a monetary heating supplement annually

We are also looking to provide income -tax filing services for the elders.

Lifeline monitoring services

#### **HENVEY WIND POWER**

MFN Chief and Council are working on a draft compensation agreement to address the need for Henvey to run power lines through the entire length of MFN.

Negotiations include the possibility for MFN to supply Henvey the aggregate needed for the wind power project from our Quarry. This also requires MFN to obtain a partner to provide the capacity operate the Quarry. Miler Paving is a candidate who we have been in discussion with.

There is also an opportunity to venture into the forest clearing of the route required to run the power lines from Henvey to Parry Sound. We have also had discussion with a potential partner to undertake the sub-contractor project. It also requires MFN to obtain the rights to a contract from the contracting company that has been awarded the contract to run the lines.

#### **MTO HIGHWAY**

Chief and Council is currently engaged with our team in the preparation of settlement agreement to present to MTO to venture into negotiations for a compensation settlement for the land use requirement on our Reserve. This process will be ongoing until our ducks are all in a row and we meet with the membership to obtain their support to move forward with the negotiations with MTO to reach a settlement...

Chief and council are in the process of finalizing the terms and requirements for an agreement to settle the reconciliation issue. This process will be ongoing until our ducks are all in a row at which time we will meet with the membership to obtain their support to move forward with the negotiations with MTO to reach a settlement.

MTO repayed 529 to allow for a walkway on the north side from Village Road to the Band Office

#### OFNLP - OLG

2015-17 - Council CONTINUES utilized investment funds in order to meet the shortfalls, subsidize areas where sufficient funding is not provided and to fund the monthly budget established to provide for the community. (Food vouchers - Easter, Thanksgiving and Xmas, Heating supplement, Addictions week, Xmas Gathering/Party, etc.)

The monthly distributions are flowing on time.

#### **ONTARIO GRAPHITE LIMITED**

There has not been any new development in the reopening of the Graphite mine which has been put on hold by OGL. MFN is patiently awaiting the continuation of the negotiations agreed to in an MOU.

#### NOTE

Canada has refused to provide Magnetawan funding necessary to adequately explore this issue.

Magnetawan will be seeking the assistance and advice from the Union of Ontario Indians on Canada's partial acceptance of the CPR Claim. It is expected that as part of this advice Magnetawan will consider the Specific Claims Tribunal as an option to seek a just resolution of all of the claims.

# Robinson Huron Treaty Annuities Litigation

The legal proceedings are still underway. A 'summary judgment motion' has been submitted to the court. The legal team is busy preparing for court hearings that will occur in the summer of 2017. Information pertaining to the matter must remain confidential.

Chief and Council establish an annual budget to provide events to support activities that will provide for community togetherness and well being.

#### Annual Wild Game Harvest:

An arrangement was made with MNR to provide wild game to MFN from animals confiscated or acquired from road kill. We received Moose and deer in January of both 2016 and 2017. We use the meat for distribution to members and elders in need and community events.

We take this opportunity to acknowledge and extend our appreciation to MFN citizen Jessie Salt who generously takes of his time to harvests a moose annually for distribution to every MFN household.

#### Annual summer picnic and Pig Roast

This event has brought our families together for an enjoyable day, fun and games and to top it off a pig roast feast with all the trimmings.

I also acknowledge my good friends Donny and Lucy Cole for their generous donation and time to participate with us in providing the pig, corn and the roasters. Approximately 140 attended and from the comments received, all had a great time especially the children.

#### Annual Christmas Party and Feast

This past years gathering had over 200 registered to attend. Even with the snow storm we had 160 attendees.

#### **Annual Wonderland Trip**

Participation was exceptional and all that attended enjoyed their day both years.

#### Annual Aboriginal Day – June 21

A celebration of our day is held annually including a fishing derby, BBQ picnic and a fireworks display put on by Councillor Lloyd Myke

#### Easter, Thanksgiving and Christmas

Gift cards are provided to all the households to assist with providing a family dinner.

#### Mothers and Fathers Day

The mothers and fathers are acknowledged and provided a gift

Based on the bacteriological results of these latest samples, the water plant servicing your community appears to be functioning as per its design and the water supply is considered safe for consumption. # COUNCILLOR'S CORNER:

Greetings All, I just wanted to give you a brief update on some of the great initiatives we have undertaken and successfully passed and ratified as we continue moving Magnetawan First Nation forward, in a positive way that strengthens our political position in key areas.

- 1. Constitution—Anishnabek Education System: MFN took a huge step forward as a nation to successfully ratify its own Constitution. This will be our corner stone and building block for the community to create and pass its own laws, for the years ahead, leading to our own determination of self government.
- 2. A.E.S.—Education: Again MFN citizens have determined that our children and future children's education will be run by F.N. control. The A.E.S. system will become live April 1, 2018. It has been a privilege and honor to sit as chairman of the board for Anishnabek Nation to successfully ratify this agreement with Canada and Ontario. History in the making and such a great moment to know we have moved away from INAC funding and control to F.N. control over our children's educations.
- 3. Anishnabek— Child well being/CAS delivery: We have again taken great steps forward to having our own child welfare system being run by our First Nations and taken control of delivery of our children and out of the outdated CAS. As President of the board for our Tribal Council, with direction from area Chiefs we have begun the process of designation and next steps forward.

These are just a few of the important initiatives that MFN has undertaken and as we continue to move the yard sticks forward. It is very exciting times in Anishnabek Nation right now for MFN. We are active partners and our voices are heard and with the membership driving these successful ventures forward, we will continue to lead the way for the betterment of all MFN citizens.
